### **Project spotlight**

Xenith was engaged to undertake a fugitive emissions estimate and a concept study to identify solutions to reduce Scope 1 emissions for one of the largest open cut coal mining operations in Australia. The study was undertaken by a multidisciplinary team comprising gas specialists, geologists, mining engineers and business analysts.

It was completed in compliance with NGER's (National Greenhouse and Energy Reporting) requirements and included geological modelling of 11 gas boreholes. Coal seam gas onsite power and other flaring options were designed and cost modelled. Scenarios with various gas drainage drillhole spacing and seam gas utilisation (flaring, transportation, power generation) were modelled to allow a reduction of the open cut mine Scope 1 emissions. A data check process was undertaken to ensure accurate and reliable data was available to the client for their investment decisions, as part of the company's decarbonisation strategy.
